2. DECLARATION OF INTERESTS – Cllr Fairs referred to the planning application for Warrens Farm, and said that although he rents a unit at Warrens Farm, he has nothing to do with the business.

3. CONFIRMATION OF MINUTES OF LAST PARISH COUNCIL MEETING.

The minutes of the last parish council meeting of 12th April 2005 were agreed as a true record, and signed.

4. MATTERS ARISING FROM THE MINUTES

Cllr Traube said that the bus shelter would be delivered on 20th May. He is following up with Essex County Council the question of the hardstanding on the village hall side of Chappel Road.

7. VILLAGE HALL ALTERATIONS AND FUND RAISING

The question of whether the Parish Council should fund the village weekend was discussed. It was agreed that assistance to the extent of 1,000 be made available, and an initial payment of £500 in favour of Great Tey Golden Jubilee Fund was agreed.

8. THE ROAD FROM A120 TO CHAPPEL CORNER.

This item is to be carried forward to next month's agenda.

9. SPECIAL GRANT OF £1,000 FROM ESSEX COUNTY COUNCIL.

This grant has been made available for IT or for community projects. It was agreed in principle to fund a printer for the clerk, either laser or inkjet, and the clerk will liase with Cllr Fairs concerning quotations, which will be considered at the next meeting.

10. CORREPONDENCE NOT DEALT WITH ELSEWHERE

Details concerning the new licensing regulations have been received and passed to Cllr Bartleet concerning the village weekend requirements.

Colchester Borough Council has confirmed that it is the responsibility of the parish council to maintain the public seat outside the shop. It was agreed therefore that the clerk asks the handyman to rub down and varnish the seat and also the parish notice board outside the shop.

PUBLIC QUESTIONS

i)The cutting of the road verges have been taken over by Essex County Council from Colchester Borough Council and are not being cut until the end of June by Essex County Council, who are only cutting them twice a year.

ii) Is the parish council aware that the helicopter school at Earls Colne has submitted a new planning application?

11. OTHER BUSINESS FOR DISCUSSION

Following the public questions, it was agreed that the clerk write to Essex County Council and ask them to bring forward the cuts as the grass is high and can be considered dangerous on some roadsides.

It was also agreed that the clerk write to Braintree District Council to obtain details of the helicopter school planning application and forward to councillors for information.
